APPLICATION RATES AND TIMINGS

Apple: 5 to 10 l/ha at bud burst. Repeat at petal fall. For premature leaf fall (e.g. Golden Delicious): two to five applications of 5 to 10 l/ha from fruit set onwards, at 10 to 14 day intervals. Do not apply within one month of harvest. Water rate: 200 l/ha.

Cherry: Two applications of 5 to 10 l/ha between bud burst and start of flowering. Also, two to five applications of 5 to 10 l/ha from fruit set onwards, at 7 to 14 day intervals. Do not apply within one month of harvest. Water rate: 200 l/ha to 2000 l/ha.

Grapevines: Three applications of 2.5 to 5 l/ha at stages flower truss visible, flower buds separated, start of flowering and cap fall/fruit set. Water rate: 200 l/ha. Pears: 5 to 10 l/ha at bud burst. Also, two to five applications of 5 to 10 l/ha from fruit set onwards, at 10 to 14 day intervals. Do not apply within one month of harvest. Water rate: 200 l/ha.

Plum: Two applications of 5 to 10 l/ha between bud burst and start of flowering. Also, two to five applications of 5 to 10 l/ha from fruit set onwards, at 10 to 14 day intervals. Do not apply within one month of harvest. Water rate: 200 to 2000 l/ha.

Strawberry (Field Grown): 5 l/ha at the start of new season leaf growth. Repeat twice at 10 to 14 day intervals. Water rate: 200 l/ha.

DIRECTIONS FOR USE

ALWAYS FOLLOW THESE LABEL INSTRUCTIONS Mix the product thoroughly before use. Slowly add the product to the tank, via the induction hopper, whilst agitating. Top up with water and continue to agitate until spraying is completed.
